Product & Equipment Branding & Compliance Plates

From the beginning of December 2017 product and equipment in the process of being manufactured will no longer include the TOSHIBA brand name and for a period of time there will be no company branding appearing on newly manufactured systems. It is expected that the CANON brand should start appearing on production systems from the end of the second quarter in 2018. However, the TOSHIBA logo may remain in place on some *components* of a system for a period of time.

With regard to compliance labels (or name plates), which must conform with legal requirements for labeling, the name "Toshiba Medical Systems Corporation" will appear on all systems manufactured up to the 4th January 2018 after which "Canon Medical Systems Corporation" will be used.

Please note that there is no plan to modify the brand name of systems currently installed or apply the CANON brand to systems with no branding.
